The North Carolina Secretary of State ("NCSOS") will suspend the corporation/limited liability company for violations on behalf the NCVMB, until such time that the entity has been reinstated and returned to good standing with the Board or has been dissolved.

AMENDMENTS

A professional corporation or professional limited liability company is responsible for securing prior Board approval for all amendments (for example, entity name change, adding/removing stockholders, adding removing members, etc.) made to the original Articles of Incorporation or Articles of Organization. A copy of the Articles of Amendment must have prior Board approval before being filed with the NCSOS. Please complete the applicable sections of the application, which is required to be signed by a corporate officer or company official before a Notary Public, and submit the original with a copy of your Articles of Amendment. An approval certificate will be emailed you, which must accompany the Articles of Amendment that you submit to the NCSOS.
